## TAX WITHHOLDING FROM PENSIONS

Your monthly pension payments are subject to Federal income tax withholding <u>unless you elect NOT to have</u> withholding apply.

You may elect to have Federal income tax withheld from your pension in whole dollar amounts, by completing and submitting to this office form W-4P (Federal).

If you fail to make an election, we are required by law to withhold Federal income tax as if you were married with three withholding allowances. Starting January 1, 2019, the amount of federal tax withheld from payments (if any) may be reduced because the withholding tables have changed. If your pension payments are less than \$1,990.00 per month, no withholding will be required, unless you specifically request withholding.

If you elect not to have withholding apply, or if you do not have enough Federal income tax withheld from your pension payments, you may be responsible for payment of estimated tax. You may incur penalties under the estimated tax rules if your withholding and estimated tax payments are not sufficient.

Your election will remain in effect until you revoke it. Any subsequent election or revocation received by this Administrative Office will be put into effect by the first of the month that is at least 30 days after we receive the election form. You can make and revoke elections not to have withholding apply as often as you wish. Additional elections and W-4P forms may be obtained from the Administrative Office.
